

RDC RESOLUTION NO. 01 Series of 2021

ENDORSING TO THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) AND AGENCY CENTRAL OFFICES (ACOs) THE FY 2022 BUDGET PROPOSALS OF THE AGENCY REGIONAL OFFICES (AROs) AND STATE UNIVERSITIES AND COLLEGES (SUCs) IN METRO MANILA FOR FAVORABLE CONSIDERATION

WHEREAS, the Chairman of the Metropolitan Manila Development Authority, as Chair of both the Metro Manila Council and the Regional Development Council for the National Capital Region (RDC-NCR), is mandated under Executive Order No. 113 series of 2002 to review and endorse to the Department of Budget and Management (DBM) and the Agency Central Offices (ACOs) the annual proposed budgets of Agency Regional Offices (AROs) and State Universities and Colleges (SUCs) in the National Capital Region;

WHEREAS, the DBM, as the government agency responsible for the formulation and implementation of the National Budget, has issued the National Budget Memorandum No. 138 (NBM No. 138) last 6 January 2021 providing the prescribed guidelines and procedures in the preparation of the Fiscal Year 2022 budget proposals;

WHEREAS, the NBM No. 138 stated that "Agencies should undertake consultations and coordination with the Local Government Units (LGUs) within the Regional Development Councils (RDCs) to ensure that the national priorities are responsive to regional and local needs in a manner that LGU development capacities are strengthened in the process";

WHEREAS, the RDC-NCR conducted a 4-day Technical Budget Review/Consultation for Fiscal Year 2022 on 16, 17, 18 and 19 February 2021 via Zoom application;

WHEREAS, the RDC-NCR has thoroughly reviewed and discussed the budget proposals of 27 AROs and 8 SUCs in Metro Manila as contained in BP Form C, Annex "B" of NBM No. 138 entitled "Summary of RDC-NCR Inputs and Recommendations on the Agency New and Expanded Programs and Projects";

NOW, THEREFORE, the Regional Development Council for the National Capital Region in session duly assembled, hereby endorses the Fiscal Year 2022 budget proposals of the Agency Regional Offices and State Universities and Colleges in Metro Manila to the DBM and their respective Agency Central Offices for favorable consideration.
