



**COMMITTEE ON AWARD  
Resolution No. 17-063  
April 17, 2017**

**WHEREAS**, on April 7, 2017, the Bids and Awards Committee conducted a Public Bidding for the Supply and delivery of five (5) units of AUV;

**WHEREAS**, Invitation to Bid No. 011 -2017-GOODS-FIN. AND ADMIN. for Purchase Request No. 17-01-114 was advertised in accordance with law;

**WHEREAS**, in response to the call for bids, seven (7) prospective bidders were able to log-in in the Philgeps, but only **TOYOTA QUEZON AVENUE, INC.** purchased the Bid Documents;

**WHEREAS**, at the time of the bidding, only one bidder was in attendance and submitted the technical and financial proposal;

**WHEREAS**, the first envelope containing the technical component of the bid, including the eligibility requirements of the lone bidder was opened and rated "passed" and eligible to proceed to the next stage, which is the opening of the financial proposal;

**WHEREAS**, the second envelope containing the financial proposal of **TOYOTA QUEZON AVENUE, INC.** was opened and the result was as follows:

**WHEREAS**, the post qualification of the single calculated bidder was conducted to verify, ascertain and evaluate their eligibility, technical and financial proposals;

**WHEREAS**, as evaluated using the aforementioned criteria, **TOYOTA QUEZON AVENUE, INC.** passed all of the criteria and was post qualified at the single calculated responsive bid of P5,501,000.00 (see Bid Evaluation and Post Qualification Report dated April 17, 2017)

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED**, the undersigned members of the Committee hereby recommends to award the contract for the above-mentioned requirements to **TOYOTA QUEZON AVENUE, INC.**, pursuant to Section 36.a of the Revised of RA 9184.
