



**COMMITTEE ON AWARD**  
**Resolution No. 17-023**  
**March 8, 2017**

**WHEREAS**, on February 23, 2017, the Bids and Awards Committee conducted a Public Bidding for the Supply of labor and materials for General overhauling of Mitsubishi 4D33 engine;

**WHEREAS**, Invitation to Bid No. 004 -2017-GOODS-TED.TDO for Purchase Request No. 17-01-076 was advertised in accordance with law;

**WHEREAS**, in response to the call for bids, four (4) prospective bidders were able to log-in in the Philgeps, but only HSH Auto Rebuilders purchased the Bid Documents;

**WHEREAS**, at the time of the bidding, only one bidder was in attendance and submitted the technical and financial proposal;

**WHEREAS**, the first envelope containing the technical component of the bid, including the eligibility requirements of the lone bidder was opened and rated "passed" and eligible to proceed to the next stage, which is the opening of the financial proposal;

**WHEREAS**, the second envelope containing the financial proposal of **HSH Auto Rebuilders** was opened and the result was as follows:

**WHEREAS**, the bid proposal of the lone bidder was forwarded to the TWG for bid evaluation. The submitted proposal underwent preliminary examination and comparison with the Approved Budget for the Contract (ABC), which is P132,029.52;

**WHEREAS**, the post qualification of the single calculated bidder was conducted to verify, ascertain and evaluate their eligibility, technical and financial proposals;

**WHEREAS**, as evaluated using the aforementioned criteria, **HSH Auto Rebuilders** passed all of the criteria and was post qualified at the single calculated responsive bid of P130,715.20 (see Bid Evaluation and Post Qualification Report dated March 7, 2017)

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED**, the undersigned members of the Committee hereby recommends to award the contract for the above-mentioned requirements to **HSH Auto Rebuilders**, pursuant to Section 36.a of the Revised of RA 9184.
