



WHEREAS, on December 13, 2016, the Bids and Awards Committee conducted a Public Bidding for the Supply and delivery of one (1) unit Ambulance;

WHEREAS, Invitation to Bid No. 034 -2016-GOODS-REG-TDO was advertised in accordance with law;

WHEREAS, in response to the call for bids, three (3) prospective bidders were able to log-in in the Philgeps, but only **BROADWAY MOTOR SALES CORPORATION (NISSAN UN AVENUE)** purchased the Bid Documents;

WHEREAS, at the time of the bidding, the lone bidder was in attendance and submitted the technical and financial proposal;

WHEREAS, the first envelope containing the technical component of the bid, including the eligibility requirements of the lone bidder was opened and rated "passed" and eligible to proceed to the next stage, which is the opening of the financial proposal;

WHEREAS, the second envelope containing the financial proposal of **BROADWAY MOTOR SALES CORPORATION (NISSAN UN AVENUE)** was opened and the result was as follows:

WHEREAS, the post qualification of the single calculated bidder was conducted to verify, ascertain and evaluate their eligibility, technical and financial proposals;

WHEREAS, as evaluated using the aforementioned criteria, **BROADWAY MOTOR SALES CORPORATION (NISSAN UN AVENUE)** passed all of the criteria and was post qualified at the single calculated responsive bid of P 1,599,000.00 (see Bid Evaluation and Post Qualification Report dated December 16, 2016)

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, the undersigned members of the Committee hereby recommends to award the contract for the above-mentioned requirements to **BROADWAY MOTOR SALES CORPORATION (NISSAN UN AVENUE)**, pursuant to Section 36.a of the Revised of RA 9184.
