WHEREAS, a Notice of Meeting of the Bids and Awards Committee (BAC) was issued by the BAC Secretariat on November 20, 2017 setting the Opening of bids on December 20, 2017;

WHEREAS, the said Notice was received by: a) Members of the BAC on November 20, 2017; b) TWG on November 20, 2017; and c) Commission on Audit (COA) on November 20, 2017;

WHEREAS, on December 20, 2017, the scheduled date for the opening of bids, the BAC declared the bid submitted by Abdon Antipolo Builders and Enterprise in the amount of Thirteen Million Five Hundred Thirty Five Thousand Pesos (PHP13,535,000.00) as the Lowest Calculated Bid;




