**WHEREAS**, the Budget Officer certified the existence of funds for this procurement;

**WHEREAS**, on December 05, 2018, the Metropolitan Manila Development Authority (MMDA) advertised the Invitation to Bid at MMDA website, PhilGEPS and a conspicuous place at the premises of the MMDA continuously for 7 days;

**WHEREAS**, in response to the said advertisement, one (1) prospective bidder purchased bid documents and submitted its bid on December 26, 2018 which was rated passed during the preliminary examination. Hereunder shown, as follows:




