WHEREAS, a Purchase Request (PR #18-05-529) for the Rental of Vaccum Truck, Water Jet Truck, Closed Circuit Television Van and Borescope, with an Approved Budget for the Contract of Four Million, Nine Hundred Twenty-Eight Thousand, Five Hundred Fifty Pesos (Php 4,928,550.00) was duly approved by the Head of the Procuring Entity (HOPE);

WHEREAS, on June 19, 2018, the Metropolitan Manila Development Authority (MMDA) advertised the Invitation to Bid at MMDA website, PhilGEPS and a conspicuous place at the premises of the MMDA continuously for 7 days;

WHEREAS, in response to the said advertisement, only one (1) prospective bidder purchased bid document and submitted its bid on July 9, 2018 which was rated passed during the preliminary examination. Hereunder shown, as follows:
