**WHEREAS**, a Purchase Request (PR #18-03-309) for the *Supply and Delivery of Reflectorized Stickers, Silk Screen Materials for Manufacturing of Various Traffic Road Signages and Materials for Traffic Road Facilities*, with an Approved Budget for the Contract of Seven Million Pesos (Php 7,000,000.00) was duly approved by the Head of the Procuring Entity (HOPE);

**WHEREAS**, on June 26, 2018, the Metropolitan Manila Development Authority (MMDA) advertised the Invitation to Bid at MMDA website, PhilGEPS and a conspicuous place at the premises of the MMDA continuously for 7 days;

**WHEREAS**, in response to the said advertisement, only one (1) prospective bidder purchased bid document and submitted its bid on July 16, 2018 which was rated passed during the preliminary examination. Hereunder shown, as follows:


