WHEREAS, Purchase Request No.18-04-415 dated April 16, 2018 for the project **FEASIBILITY STUDY FOR THE SAFE CLOSURE AND REHABILITATION PLAN OF CARMONA SANITARY LANDFILL** of the **Solid Waste Management Office (SWMO)** with an Approved Budget for the Contract of **Ten Million Four Hundred Twenty-Two Thousand (Php10,422,000.00)** was duly approved by the Head of the Procuring Entity (HOPE);

WHEREAS, the Budget Officer certified the existence of funds for this procurement through Earmark No. EA2018-04-0125 dated April 27, 2018 with expiration date of July 31, 2018;

WHEREAS, proper Notices of BAC Meeting for the different procurement activities relative to this procurement project were issued by the BAC;

WHEREAS, a pre-procurement meeting was held on May 2, 2018;

WHEREAS, a Request for Expression of Interest was posted on May 13, 2018 in the PhilGEPS and other sites as required by law;

WHEREAS, on June 5, 2018, the scheduled opening of the eligibility folders, only the following two bidders submitted their eligibility documents: **a) PRISM EXPRESS CONSULTING, INC.**; and **b) WOODFIELDS CONSULTANTS, INC.**; and after the opening of the folders, only **WOODFIELDS CONSULTANT, INC.** passed the eligibility check and thus, was shortlisted;

WHEREAS, a pre-bid conference was held on June 20, 2018;

WHEREAS, on July 2, 2018, during the opening and evaluation of the technical and financial proposal of the single shortlisted consultant, **WOODFIELDS CONSULTANTS, INC.** was determined to be the Single Rated Bid (SRB) with a Technical Evaluation Score of 95% and bid amount of **Ten Million Three Hundred Eighty Thousand Two Hundred Pesos (Php10,380,200.00)**;

WHEREAS, a Negotiation was held on July 4, 2018;


