WHEREAS, a Purchase Request (PR# 19-10-730) for the Supply and Delivery of 8,000 pcs. various Groceries Items for Christmas Give Aways to MMDA Employees with an Approved Budget for the Contract of Eight Million, Nine Hundred Sixty Thousand Pesos (P 8,960,000.00) was duly approved by the Head of the Procuring Entity (HOPE);
