**A RESOLUTION RECOMMENDING THE AWARD OF CONTRACT THRU
PUBLIC BIDDING FOR THE SUPPLY AND DELIVERY OF MATERIALS FOR
THE REPAIR AND REPAINTING OF CONCRETE BARRIERS**

WHEREAS, a Purchase Request (PR# 19-01-095) for the Supply and Delivery of materials for the repair and repainting of Concrete Barriers, with an Approved Budget for the Contract of One Million, Eight Hundred Fifty Eight Thousand, Nine Hundred Eighty Two Pesos and Seventy Two Centavos (P1,858,982.72) was duly approved by the Head of the Procuring Entity (HOPE);

WHEREAS, on March 8, 2019, the Metropolitan Manila Development Authority (MMDA) advertised the Invitation to Bid at MMDA Website, PhilGEPS and at conspicuous place at the premises of the MMDA;

WHEREAS, in response to the said advertisement, only one (1) prospective bidder bought the bid document and submitted its bid on March 27, 2019. The BAC during the Opening of Bids conducted on March 27, 2019 reveals that the lone bidder, MEGA FIXTURES, INC. passed the technical, legal, financial documents required;

Whereas, upon evaluation of the Financial Bids of the MEGA FIXTURES, INC. shows the following:

NOW THEREFORE, We, the members of the Bids and Awards Committee (BAC), hereby RESOLVE as it is hereby RESOLVED:


