**A RESOLUTION RECOMMENDING THE AWARD OF CONTRACT THRU
PUBLIC BIDDING FOR THE SUPPLY OF MATERIALS FOR THE
CONSTRUCTION OF CONCRETE BARRIER (IN-HOUSE IMPLEMENTATION)**

WHEREAS, a Purchase Request (PR# 19-01-094) for the Supply of materials for the construction of Concrete Barrier (In-House Implementation), with an Approved Budget for the Contract of Two Million, Four Hundred Ninety Nine Thousand, Nine Hundred Ninety Two Pesos and Thirty Two Centavos (P2,499,992.32) was duly approved by the Head of the Procuring Entity (HOPE);

WHEREAS, on March 8, 2019, the Metropolitan Manila Development Authority (MMDA) advertised the Invitation to Bid at MMDA Website, PhilGEPS and at conspicuous place at the premises of the MMDA;

WHEREAS, in response to the said advertisement, only one (1) prospective bidder bought the bid document and submitted its bid on March 27, 2019. The BAC during the Opening of Bids conducted on March 27, 2019 reveals that the lone bidder, MEGA FIXTURES, INC. passed the technical, legal, financial documents required;

Whereas, upon evaluation of the Financial Bids of the MEGA FIXTURES, INC. shows the following:
