**A RESOLUTION RECOMMENDING THE AWARD OF CONTRACT THRU
PUBLIC BIDDING FOR THE SUPPLY AND DELIVERY OF VARIOUS
COMPUTERS AND PRINTERS FOR THE USE OF SOLID WASTE
MANAGEMENT OFFICE (SWMO)**

WHEREAS, a Purchase Request (PR# 19-03-300) for the Supply and Delivery of Various Computers and Printers for the use of Solid Waste Management Office (SWMO), with an Approved Budget for the Contract of One Million, Two Hundred Seventy Nine Thousand, Five Hundred Seventy Six Pesos (P 1,279,576.00) was duly approved by the Head of the Procuring Entity (HOPE);

WHEREAS, on June 4, 2019, the Metropolitan Manila Development Authority (MMDA) advertised the Invitation to Bid at MMDA Website, PhilGEPS and at conspicuous place at the premises of the MMDA;

WHEREAS, in response to the said advertisement, only one (1) prospective bidder purchased the bid document and submitted its bid on June 24, 2019. The BAC during the Opening of Bids conducted on June 24, 2019 reveals that the lone bidder, Tekzone Computer Sales and Services Inc. passed the technical, legal, financial documents required;
