**A RESOLUTION RECOMMENDING THE AWARD OF CONTRACT THRU
PUBLIC BIDDING FOR THE PROCUREMENT OF SIX UNITS WATER
TREATMENT AND PURIFICATION SYSTEM**

WHEREAS, a Purchase Request (PR# 19-02-148) for the Procurement of Six Units Water Treatment and Purification System, with an Approved Budget for the Contract of Twenty Eight Million Four Hundred Thousand Pesos (P 28,400,000.00) was duly approved by the Head of the Procuring Entity (HOPE);

WHEREAS, on March 16, 2019, the Metropolitan Manila Development Authority (MMDA) advertised the Invitation to Bid at MMDA Website, PhilGEPS and at conspicuous place at the premises of the MMDA;

WHEREAS, in response to the said advertisement, only one (1) prospective bidder purchased the bid document and submitted its bid on April 8, 2019. The BAC during the Opening of Bids conducted on April 8, 2019 reveals that the lone bidder, S&S ENTERPRISES, INC. passed the technical, legal, financial documents required;
