

**COMMITTEE ON AWARD
Resolution No. 16-045
March 2, 2016**

WHEREAS, on February 4, 2016, the Bids and Awards Committee conducted a Public Bidding for the Supply and delivery of brand new AUV passenger type (14-16 seater);

WHEREAS, Invitation to Bid No. 003-2016-GOODS-METROBASE was advertised in accordance with law;

WHEREAS, in response to the call for bids, nine (9) prospective bidders were able to log-in in the Philgeps, but only **GENCARS INC.-ISUZU MAKATI** purchased the Bid Documents;

WHEREAS, at the time of the bidding, the lone bidder was in attendance and submitted the technical and financial proposal;

WHEREAS, the first envelope containing the technical component of the bid, including the eligibility requirements of the lone bidder was opened and rated "passed" and eligible to proceed to the next stage, which is the opening of the financial proposal;

WHEREAS, the second envelope containing the financial proposal of **GENCARS INC.-ISUZU MAKATI** was opened and the result was as follows:

WHEREAS, the bid proposal of the lone bidder was forwarded to the Technical Working Group for post evaluation. The submitted proposal underwent preliminary examination and comparison with the Approved Budget for the Contract (ABC), which is P 1,280,000.00;

WHEREAS, the post qualification of the lone bidder was conducted to verify, ascertain and evaluate their eligibility, technical and financial proposals;

WHEREAS, as evaluated using the aforementioned criteria, **GENCARS INC.-ISUZU MAKATI** passed all of the criteria and was post qualified at the single calculated responsive bid of P 1,275,000.00 (see Bid Evaluation Report dated March 2, 2016)

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, the undersigned members of the Committee hereby recommends to award the contract for the above-mentioned requirements to **GENCARS INC.-ISUZU MAKATI**, pursuant to Section 36.a of the Revised IRR of RA 9184.
