

**COMMITTEE ON AWARD
Resolution No. 16-143
May 19, 2016**

WHEREAS, on April 12, 2016, the Bids and Awards Committee conducted a public bidding for Hiring of 163 Security Guards;

WHEREAS, Invitation to Bid No. 014-2016- SERVICES-ADMIN. SERVICE for Purchase Request No. 16-03-210 was advertised in accordance with law;

WHEREAS, in response to call for bids, ten (10) prospective bidders were able to log-in in the PhilGEPS, but only one (1) bidder, **SUPERB SECURITY AND INVESTIGATION AGENCY, INC.** purchased the Bid Document;

WHEREAS, at the time of the bidding, the lone bidder was in attendance and submitted their technical and financial proposal;

WHEREAS, the first envelope, containing the technical component of the bid, including the eligibility requirements of the lone bidder was opened and rated "passed", therefore, eligible to proceed to the next stage, which is the opening of the financial proposal;

WHEREAS, the second envelope containing the financial proposal of **SUPERB SECURITY AND INVESTIGATION AGENCY, INC.** was opened and the result was as follows:

WHEREAS, the bid proposal of the lone bidder was forwarded to the TWG for Bid evaluation. The submitted proposal underwent preliminary examination and comparison with the Approved Budget for the Contract (ABC), which is P 4,075,000.00;

WHEREAS, the post qualification of the single calculated bidder was conducted to verify, ascertain and evaluate their eligibility requirements, technical and financial proposals;

WHEREAS, as evaluated using the aforementioned criteria, **SUPERB SECURITY AND INVESTIGATION AGENCY, INC.** passed all of the criteria and was **post qualified** at the single calculated responsive bid of P 3,423,000.00 (see Bid Evaluation and Post Qualification Report dated May 19, 2016);

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, the undersigned members of the Committee hereby recommends to award the contract for the above-mentioned services to **SUPERB SECURITY AND INVESTIGATION AGENCY, INC.** pursuant to Section 36.a of the Revised of RA 9184.
