**COMMITTEE ON AWARD**  
**Resolution No. 15-380**  
**December 29, 2015**

**WHEREAS**, per BAC Resolution No. 15-326A dated November 13, 2015, the Committee declared a failed bid and recommended the re-advertisement for the Supply and Delivery of Rescue Uniform for Public Safety Division;

**WHEREAS**, on November 16, 2015, the Authority re-invited all interested bidders to apply for eligibility and to bid for the said requirement;

**WHEREAS**, the re-invitation No. 056-2015-GOODS-PSD, to bid was advertised in accordance with law;

**WHEREAS**, in response to the call for bids, there were six (6) prospective bidders who were able to log-in in the PhilGEPS, but only one, Sejam General Enterprises, purchased the bid documents;

**WHEREAS**, at the time of the bidding, the lone bidder was in attendance and submitted their technical and financial proposal;

**WHEREAS**, the first envelope containing the technical component of the bid, including the eligibility requirements of the lone bidder was opened and rated "passed" and eligible to proceed to the next stage, which is the opening of the financial proposal;

**WHEREAS**, the second envelope containing the financial proposal of the lone bidder was opened and the result was as follows:

**WHEREAS**, the bid proposal of the lone bidder was forwarded to the end user for post evaluation. The submitted proposal underwent preliminary examination and comparison with the Approved Budget for the Contract (ABC), which is P 613,200.00;

**WHEREAS**, the post qualification of the lone bidder was conducted to verify, ascertain and evaluate their eligibility, technical and financial proposals;

**WHEREAS**, as evaluated using the aforementioned criteria, **Sejam General Enterprises**, passed all of the criteria and was post qualified at the single calculated responsive bid of P 611,800.00 (see Post Evaluation Report dated December 28, 2015)

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED**, the undersigned members of the Committee hereby recommends to award the contract for the above-mentioned requirements to **Sejam General Enterprises**, pursuant to Section 36.a of the Revised of RA 9184.
