Resolution No. 16- 213**

**WHEREAS**, on June 7, 2016, the Bids and Awards Committee conducted a Public Bidding for the Supply of labor and materials for the repair and maintenance of KIA Double Cab with Plate Nos. SGZ 111; SGZ 232; SGZ 832; SGZ 262; SGZ 221;

**WHEREAS**, Invitation to Bid No. 020-2016-GOODS-FCSMO was advertised in accordance with law;

**WHEREAS**, in response to the call for bids, eleven (11) prospective bidders were able to log-in in the Philgeps, but only **TRI-GLOBE TRANSPORT SERVICES AND TRADING, INC.** purchased the Bid Documents;

**WHEREAS**, at the time of the bidding, the lone bidder was in attendance and submitted the technical and financial proposal;

**WHEREAS**, the first envelope containing the technical component of the bid, including the eligibility requirements of the lone bidder was opened and rated "passed" and eligible to proceed to the next stage, which is the opening of the financial proposal;

**WHEREAS**, the second envelope containing the financial proposal of **TRI-GLOBE TRANSPORT SERVICES AND TRADING, INC.** was opened and the result was as follows:

**WHEREAS**, the bid proposal of the lone bidder was forwarded to the TWG for bid evaluation. The submitted proposal underwent preliminary examination and comparison with the Approved Budget for the Contract (ABC), which is P 965,600.00;

**WHEREAS**, the post qualification of the single calculated bidder was conducted to verify, ascertain and evaluate their eligibility, technical and financial proposals;

**WHEREAS**, as evaluated using the aforementioned criteria, **Tri-Globe Transport Services and Trading, Inc.**, passed all of the criteria and was post qualified at the single calculated responsive bid of P 961,500.00 (see Bid Evaluation and Post Qualification Report dated June 16, 2016)

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED**, the undersigned members of the Committee hereby recommends to award the contract for the above-mentioned requirements to **TRI-GLOBE TRANSPORT SERVICES AND TRADING, INC.**, pursuant to Section 36.a of the Revised of RA 9184.
