

**COMMITTEE ON AWARD**  
**Resolution No. 16-022**  
**February 12, 2016**

**WHEREAS**, on January 28, 2016, the Bids and Awards Committee conducted a public bidding for the Supply and delivery of materials for the Fabrication, installation and maintenance of Traffic Road Signages and Traffic Road facilities (as per request of Barangay's, LGU's, Schools, Churches, Government Offices and for the maintenance of Public Parks and Roads);

**WHEREAS**, Invitation to Bid No. 002-2016-GOODS-TED for Purchase Request No. 15-10-947 was advertised in accordance with law;

**WHEREAS**, in response to the call for bids, fifteen (15) prospective bidders were able to log-in in the PhilGEPS, but only one (1) bidder, Epic Industrial Sales Corp. purchased the Bid Document;

**WHEREAS**, at the time of the bidding, the lone bidder was in attendance and submitted their technical and financial proposal;

**WHEREAS**, the first envelope, containing the technical component of the bid, including the eligibility requirements of the lone bidder was opened and rated "passed", therefore, eligible to proceed to the next stage, which is the opening of the financial proposal;

**WHEREAS**, the second envelope containing the financial proposal of Epic Industrial Sales Corp. was opened and the result was as follows;

**WHEREAS**, the bid proposal of the lone bidder was forwarded to the End-user for post evaluation. The submitted proposal underwent preliminary examination and comparison with the Approved Budget for the Contract (ABC), which is **P2,477,655.11**;

**WHEREAS**, the post qualification of the lone bidder was conducted to verify, ascertain and evaluate their eligibility requirements, technical and financial proposals;

**WHEREAS**, as evaluated using the aforementioned criteria, Epic Industrial Sales Corp. passed all of the criteria and was post qualified at the single calculated responsive bid of P 2,474,294.00 (see Bid Evaluation & Post Qualification Evaluation Report dated February 11, 2016);

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED**, the undersigned members of the Committee hereby recommends to award the contract for the above-mentioned requirements to Epic Industrial Sales Corp.
