The *Government of the Philippines* (hereinafter called "Borrower") has received financing from the *International Bank for Reconstruction and Development and the Asian Infrastructure Development Bank and World Bank* (the "Bank") in the form of a loan (hereinafter called *loan*) toward the cost of *The Metro Manila Flood Management Project-Phase 1*. The Metropolitan Manila Development Authority (hereinafter, MMDA), an implementing agency of the Borrower, intends to apply a portion of the proceeds of this *loan* to eligible payments under the contract for which this Request for Proposals is issued. Payments by the Bank will be made only at the request of the *MMDA* and upon approval by the Bank, and will be subject, in all respects, to the terms and conditions of loan agreement. The *loan* agreement prohibits a withdrawal from the *loan* of goods, if such payment or import, to the knowledge of the Bank, is prohibited by a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations. No party other than the *Borrower* shall derive any rights from the *loan* agreement or have any claims to the proceeds of the *loan*.

The Borrower now invites proposals to provide the following consulting services (hereinafter called "Services"): *Planning and Demonstration of Community-Based Solid Waste Management Initiatives in Priority Project Drainage Areas*.
