

**COMMITTEE ON AWARD  
Resolution No. 15-206  
August 5, 2015**

**WHEREAS**, on July 10, 2015, the Bids and Awards Committee conducted a re-bidding for the Supply and Installation of various supplies & materials for the Construction of waiting Shed at Pateros Elementary School, Pateros City;

**WHEREAS**, Re-Invitation to Bid No. 027A-2015-GOODS-TEC/TED for Purchase Request No. 15-04-476 was advertised in accordance with law;

**WHEREAS**, in response to the call for bids, eight (8) prospective bidders were able to log-in in the PhilGEPS, but only one (1) bidder, BSA 99 Enterprises, Inc. purchased the Bid Document;

**WHEREAS**, at the time of the bidding, the lone bidder was in attendance and submitted their technical and financial proposal;

**WHEREAS**, the first envelope containing the technical component of the bid, including the eligibility requirements of the lone bidder was opened and found to be complete and eligible to proceed to the next stage, which is the opening of the financial proposal;

**WHEREAS**, the second envelope containing the financial proposal of **BSA 99 Enterprises, Inc.** was opened and the result was as follows;

**WHEREAS**, the financial proposal was forwarded to the End-user for evaluation and comparison with the Approved Budget for the Contract (ABC) which is **P587,227.00**;

**WHEREAS**, the post qualification of the lone bidder was conducted to verify, ascertain and evaluate their eligibility requirements, technical and financial proposals;

**WHEREAS**, as evaluated using the aforementioned criteria, **BSA 99 Enterprises Inc.**, passed all of the criteria and was post qualified at the single calculated responsive bid of P 585,947.63 (see Bid Evaluation Report dated August 4, 2015);

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED**, the undersigned members of the Committee hereby recommends to award the contract for the above-mentioned requirements to **BSA 99 Enterprises, Inc.**, pursuant to Section 36.a of the Revised IRR of RA 9184.
