Resolution No. 16-278
October 11, 2016

WHEREAS, pursuant to MMC Resolution No. 14-05, Series of 2014 entitled "Resolution Fully Supporting the New Establishment of the Pasig River Ferry System" the MMDA operates a number of ferry boats which provide water-based transportation along Pasig River to constituent of Metro Manila from Brgy. Pinagbuhatan in Pasig City to Intramuros Manila;


WHEREAS, as it is necessary to keep the boat in proper operating conditions, including preventive and routine maintenance, to ensure primarily the safety and comfort of the passenger, Invitation to Bid (ITB) No. 017-2016-GOODS-FCSMO was published on June 17, 2016 inviting bidders to 1 lot Supply and Delivery of spare parts for Ferry Boats No. F10, F11, F12, F13, F14 and F15 to which eight (8) prospective bidder/s were able to response by logging-in to the PhilGEPS, albeit not one of those who logged in purchased the Bid Documents and appeared on Opening of bids set on July 8, 2016. Hence BAC Resolution No. 16-277 dated October 4, 2016 declaring failure of bidding and recommending to re-advertise;

WHEREAS, Section 50c of the Revised IRR of Republic Act 9184 otherwise known as "An Act providing for modernization, standardization and regulation of the procurement activities of the government and for other purposes" provides that "Those sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the GOP;

WHEREAS, verification shows subject PR No. 16-05-444 seeks the purchase of 71 pcs Oil Filter Mercruiser, 72 pcs. Fuel Filter Mercruiser and 18 pcs Impeller for the purpose of preventive maintenance of said Ferry Boats; further verification shows that Mercury 220 hp Diesel Inbound Engine (Brand New) was utilized on subject ferries (Acknowledgement Receipt for Equipment Nos. 2015-0951, 2015-0631, 2015-0530, 2016-0153;


