EMPLOYEES WHO ARE NOT ENTITLED TO PERFORMANCE-BASED BONUS (PBB C.Y. 2013) PURSUANT TO MEMORANDUM CIRCULAR NO. 2013-01 SECTION 8.1 PARAGRAPH j., stated as:

"Personnel found guilty of administrative and/or criminal cases filed against them and meted penalty in FY 2013 shall not be entitled to the FY 2013 PBB. If the penalty meted out is only reprimand, such penalty shall not cause the disqualification to the PBB."
