URGING THE LOCAL GOVERNMENT UNITS OF METRO MANILA TO DEPUTIZE THE METROPOLITAN MANILA DEVELOPMENT AUTHORITY PERSONNEL IN THE IMPLEMENTATION OF THEIR RESPECTIVE TRAFFIC MANAGEMENT CODES OR ORDINANCES REGARDING ANTI-JAYWALKING

WHEREAS, Republic Act No. 7924 mandates the Metropolitan Manila Development Authority (MMDA) to provide transport and traffic management services in the metropolis;

WHEREAS, the Local Government Units of Metro Manila all have a traffic management code or an ordinance pertaining to Anti-Jaywalking;

WHEREAS, by way of mutual aid and cooperation, it is advantageous for the Local Government Units of Metro Manila to deputize the MMDA Personnel in the implementation of said traffic management code or ordinance regarding Anti-Jaywalking;

NOW, THEREFORE, be it resolved, as it is hereby resolved, that the Metro Manila Council hereby urges the Local Government Units of Metro Manila to deputize the Metropolitan Manila Development Authority Personnel in the implementation of their respective traffic management codes or ordinances regarding Anti-Jaywalking subject to the prescribed rules and regulations of said Local Government Units.

This Resolution shall be effective five (5) days after its publication in two (2) newspapers of general circulation and submission of a copy thereof with the Office of the National Administrative Register, U. P. Law Center.


