**FULLY SUPPORTING THE RETENTION OF METROPOLITAN MANILA
DEVELOPMENT AUTHORITY FOR EFFICIENT AND EFFECTIVE DELIVERY
OF METRO-WIDE SERVICES IN METROPOLITAN MANILA**

WHEREAS, Republic Act No. 7924 (RA 7924) an Act Creating the Metropolitan Manila Development Authority (MMDA) empowers the MMDA to administer the affairs of Metropolitan Manila in line with the policy of the state to treat Metropolitan Manila as a special development and administrative region for an efficient and effective delivery of metro-wide services with metro-wide impact that transcends legal political boundaries or entail huge expenditures such that it would not be viable for said services to be provided by the individual local government units (LGUs) comprising Metropolitan Manila without prejudice or diminution of the autonomy of said LGUs concerning purely local matters;

WHEREAS, since its inception, MMDA has provided and delivered metro-wide services and metro significant projects, programs and activities in the thirteen (13) cities and four (4) municipalities of Metro Manila as mandated by RA 7924, such as development planning, transport and traffic management, solid waste disposal and management, flood control and sewerage management, urban renewal, zoning, land use planning and shelter services, health and sanitation, urban protection and pollution control and public safety;

WHEREAS, the Metro Manila Council recognizes the need for a metropolitan body that would play a distinct and critical role in addressing concerns for a metropolis as huge and as complex as Metropolitan Manila;

WHEREAS, the Metro Manila Council strongly believes that MMDA's existence is necessary to respond to the rapid urbanization problems of Metropolitan Manila for efficient and effective administration, management, coordination and delivery of metro-wide services and metro significant projects, programs and activities.


