URGING THE MMDA TO CONSULT THE METRO MANILA COUNCIL ON ALL PROJECTS TO BE IMPLEMENTED BEFORE ENDORSING THESE TO THE OFFICE OF THE PRESIDENT

WHEREAS, the Metro Manila Council is the governing board and policy-making body of the MMDA composed of the Mayors of the seventeen (17) Local Government Units (LGUs) and Presidents of Vice Mayors League and Councilors League of Metro Manila;

WHEREAS, Section 6(b) of RA 7924 provides that the Metro Manila Council shall approve metro-wide plans, programs and projects and issue rules and regulations and resolutions deemed necessary by MMDA to carry out its mandated functions;

WHEREAS, there had been instances where the members of the Metro Manila Council were not consulted on projects that were endorsed to the Office of the President;

WHEREAS, the Appropriations Committee thru its Chairperson, Hon. Feliciano R. Belmonte, Jr., endorsed the Committee Resolution entitled "*Urging the MMDA to consult the Metro Manila Council on all Projects to be Implemented Before Endorsing this to the President*" to the members of Metro Manila Council (Council) for their approval and cited the significance of consulting them with regard to project conceptualization and approval in order to allow every member to actively participate in crafting said projects and likewise air their decisions and opinions relative thereto;

WHEREAS, the Metro Manila Council, in session duly assembled, after due deliberation, recognized the important role of every Council member in the conceptualization and approval of projects before endorsing the same to the Office of the President.

NOW, THEREFORE, be it resolved as it is hereby resolved, pursuant to Section 6 of RA 7924, that the Council hereby urges the MMDA to consult the Members of the Council on all projects to be implemented outside of the approved MMDA budget before endorsing these to the Office of the President.
