**MMDA Resolution No. 08-13
Series of 2008**

**AUTHORIZING THE GRANT OF OCCUPATIONAL RISK DUTY PAY (ORDP)
TO MMDA TRAFFIC ENFORCERS**

WHEREAS, it is a common knowledge that traffic enforcers deployed in the field are generally exposed to unhealthy surroundings due to smoke, gas fumes, mist and dusts particles emanating from motor vehicles operating in Metropolitan Manila;

WHEREAS, the exposure to different elements such as heat, cold and changing weather conditions could affect the health and wellbeing of the said employees;

WHEREAS, the work of traffic enforcers poses risk and danger to their lives caused by arrogant and reckless motorists/commuters;

WHEREAS, Section 6 (c) of RA 7924 empowers the Metro Manila Council to fix the compensation of the officers and personnel of the MMDA;

WHEREAS, the Metro Manila Council (Council) in session duly assembled, after due deliberation, recognized the need to grant occupational risk duty pay to MMDA traffic enforcers.

NOW, THEREFORE, be it resolved as it is hereby resolved, pursuant to Section 6 of RA 7924, that the Council hereby authorizes the grant of occupational risk duty pay to MMDA Traffic Enforcers who, in the performance of their actual duties directly expose themselves to risk;

RESOLVED FURTHER, that the entitlement of Occupational Risk Duty pay shall automatically cease the moment the concerned employees are reassigned/transferred to another offices.

RESOLVED FURTHERMORE, that the grant of ORDP shall not be less than ten percent (10%) nor more than thirty percent (30%) of the monthly salary of the concerned MMDA Traffic Enforcer, subject to availability of funds and accounting and auditing rules and regulations.




RESOLVED MUCH FURTHERMORE, that the Chairman is hereby authorized to issue implementing rules and regulations for the purpose.


RESOLVED FINALLY, that the payment of Occupational Risk Duty Pay to concerned employees shall take effect on January 1, 2009.
