**MMDA Resolution No. 09-06
Series of 2009**

RATIFYING THE DEED OF DONATION EXECUTED BY MMDA (DONOR) IN FAVOR OF THE MUNICIPALITY OF CARMONA, CAVITE (DONEE), OVER THE TEN (10) HECTARES OF LAND PORTION OF THE CARMONA SANITARY LANDFILL SITUATED AT SITIO PALIGAWAN MATANDA, CARMONA, CAVITE

WHEREAS, MMDA is the absolute and registered owner of a parcel of land situated in the Sitio Paligawan Matanda, Municipality of Carmona, Province of Cavite, containing an area of **SIX HUNDRED FIFTY NINE THOUSAND NINE HUNDRED EIGHTY FOUR (659,984.00)** square meters, more or less;

WHEREAS, the said property was acquired by then MMC now MMDA, for the specific purpose of putting up a sanitary landfill to address the problem of the National Capital Region on solid waste disposal;

WHEREAS, then MMC now MMDA, pursuant to the Declaration of Unilateral Commitment to the People of Carmona, Province of Cavite, executed on May 10, 1993 and the Memorandum of Agreement (MOA) entered into by and between the MMDA and the Municipality of Carmona, Cavite, dated June 20, 1997, has agreed to turn-over by way of Donation to the said Municipality the ownership and possession of ten (10) hectares of land, a portion of the above-described property;

WHEREAS, on June 3, 2009, the MMDA represented by the Honorable Chairman Bayani F. Fernando, executed a Deed of Donation over the said ten (10) hectares parcel of land to the Municipality of Carmona, Cavite, represented by Mayor Roy M. Loyola.

WHEREAS, the Metro Manila Council (Council) deems it proper to ratify the Deed of Donation executed on June 3, 2009 by MMDA thru the Hon. Chairman Bayani F. Fernando, duly accepted by the Municipality of Carmona, Province of Cavite, over that ten (10) hectares parcel of land located at the Sitio Paligawan Matanda, Carmona, Cavite, pursuant to Declaration of Unilateral Agreement to the People of Carmona, Province of Cavite, and the Memorandum of Agreement entered into by and between the Authority and that Municipality;

NOW, THEREFORE, be it resolved as it is hereby resolved, pursuant to Section 6 of RA 7924, that the Council hereby ratifies the Deed of Donation dated June 3, 2009 executed by and between MMDA and the Municipality of Carmona, Cavite, over that ten (10) hectares of land located at the Sitio Paligawan Matanda, Carmona, Cavite, subject to the terms and conditions contained in the Declaration of Unilateral Agreement, among which is for the DONEE to secure a certificate from Department of Environment and Natural Resources (DENR) that the said lot is environmentally stable and safe for public use and for the DONOR to be granted right-of-way and access to the remainder of its property located thereat.




