**MMDA Resolution No. 09-10**

### **CONCURRING THE APPOINTMENT OF THE ASSISTANT GENERAL MANAGER FOR OPERATIONS OF THE METROPOLITAN MANILA DEVELOPMENT AUTHORITY**

**WHEREAS**, pursuant to RA 7924 the Chairman shall be assisted by a General Manager, an Assistant General Manager for Finance and Administration, an Assistant General Manager for Planning and an Assistant General Manager for Operations, all of whom shall be appointed by the President with the consent and concurrence of the majority of the Council, subject to civil service laws, rules and regulations. They shall enjoy security of tenure and may be removed for cause in accordance with law;

**WHEREAS**, the Honorable Chairman, in his letter to **HER EXCELLENCY PRESIDENT GLORIA MACAPAGAL-ARROYO** dated July 10, 2009 recommended **ATTY. EMMANUEL A. DE CASTRO** for appointment as Assistant General Manager for Operations, this Authority;

**WHEREAS**, on July 29, 2009, **HER EXCELLENCY PRESIDENT GLORIA MACAPAGAL-ARROYO** has appointed **ATTY. EMMANUEL A. DE CASTRO** as Assistant General Manager for Operations (AGMO) of MMDA;

**WHEREAS**, the Metro Manila Council believes that **ATTY. EMMANUEL A. DE CASTRO** is best qualified for the said position taking into consideration his seven (7) long years of service as Legal Consultant and Chief of the Legal Service of the MMDA, his active participation in special operations/programs of the Authority, his chairmanship of various committees and his knowledge and extensive experience acquired in the practice of the legal profession which is very relevant and effective in the resolution of issues confronting the MMDA in the implementation/operation of the metro-wide services rendered by the Authority;






